A Stanley Dreyfus, Lecturer on Commentaries at the Hebrew Union College-Jewish Institute of Religion, New York. A former congregational rabbi and military chaplain, he served as Director of the Rabbinical Placement Commission from 1979–1991; Chairman of the Liturgy Committee of the Central Conference of American Rabbis during the preparation of new prayer books for the American Reform Judaism.

Solomon B. Freehof (1893-1990), Rabbi of the Rodef Shalom Congregation, Pittsburgh, Pennsylvania; President of the Central Conference of American Rabbis, and the World Union for Progressive Judaism; Chair of the Responsa Committee of the Central Conference of American Rabbis. Author of *Morality after Auschwitz* (1988), *Recovering the Role of Women: Power and Authority in Rabbinic Jewish Society* (1992), *Responsa: Literary History of a Genre* (1996), and other books and numerous essays.

Walter Jacob, Senior Scholar of Rodef Shalom Congregation, Pittsburgh, Pennsylvania; Past President of the Central Conference of American Rabbis, past Chair of the Responsa Committee; President of the Freehof Institute of Progressive *Halakhah* and the Associated American Jewish Museums. Author and editor of twenty two books including *American Reform Responsa* (1983), *Contemporary*

American Reform Responsa (1987), *Liberal Judaism and Halakhah* (1988), *Questions and Reform Jewish-Answers - New Reform Responsa* (1991), *The Healing Past: Pharmaceuticals in the Biblical and Rabbinic World* (1993), *Not By Birth Alone, Conversion to Judaism* (1997).

Ruth Langer, Assistant Professor of Jewish Studies at Boston College. Author of the forthcoming *To Worship Properly: Tensions between Liturgical Custom and Halakhah in Judaism*, and numerous essays.
