RONALD A. BRAUNER is Professor of Judaic Studies at Siegal College of Judaic Studies in Cleveland, Ohio. He has previously taught at Gratz College, Temple University and Beaver College. From 1972 until 1983 he was chairman of the Rabbinic Civilization Department of the Reconstructionist Rabbinic College and Academic Dean. He is the author and editor of six books of essays dealing with all aspects of Jewish civilization through the centuries. His latest work *Thinking Jewish: The Art of Living in Two Civilizations*, 2001.

Solomon B. Freehof (1893–1990) was rabbi of the Rodef Shalom Congregation, Pittsburgh, Pennsylvania, Past President of the Central Conference of American Rabbis, and the World Union for Progressive Judaism; he was past Chair of the Responsa Committee of the Central Conference of American Rabbis, and the author of twenty-six books including eight volumes of responsa, Stormers of Heaven (1931), Modern Jewish Preaching (1941), Preface to Scripture (1950), Reform Jewish Practice (1947, 1952), The Responsa Literature (1955), The Book of Job (1958), A Treasury of Responsa (1963), New Reform Responsa (1980), Today's Reform Responsa (1990).

Walter Jacob is senior scholar of Rodef Shalom Congregation, Pittsburgh, Pennsylvania; President of the Abraham Geiger College in Berlin/Potsdam, past president of the Central Conference of American Rabbis, president of the Freehof Institute of Progressive Halakhah and the Associated American Jewish Museums. Author, editor, co-editor or translator of thirty-three books including Christianity through Jewish Eyes (1974), American Reform Responsa (1983), The Changing World of Reform Judaism (1985), Liberal Judaism and Halakhah (1988), The Second Book of the Bible: Exodus Interpreted by Benno Jacob (ed., tr.) (1992), Rabbinic-Lay Relations in Jewish Law (1993), Not by Birth Alone, Conversion to Judaism (1997), Die Exegese hat das erste Wort (2002), Beyond the Letter of the Law (2004), Sexual Issues in Jewish Law (2005), Chesed and Zedakah - From Bible to Modernity (2006).

FRANK M. LOEWENBERG is a professor emeritus at the School of Social Work, Bar-Ilan University (Israel). He was educated at Harvard, Columbia and

Wayne State University. He and his family live in Efrat, Israel. They made aliya in 1971. He is the author of many books and almost 100 professional articles. His publications include Ethical Decisions for Social Work Practice (with Ralph Dolgof, 7th ed., 2004), From Charity to Social Justice: the Emergence of Communal Institutions for the Support of the Poor in Ancient Judaism, (New Brunswick NJ, 2001), and Religion and Social Work Practice in Contemporary American Society, (New York, Columbia University Press, 1988).

RICHARD RHEINS is the Senior Rabbi of Temple Sinai, Denver, Colorado. He is a past member of the Responsa Committee opf the Central Conference of American Rabbis and continues as a corresponding member. He has previously contributed to the Freehof Institute with "The Professionalization of the Rabbinate" in Rabbinic-Lay Relations in Jewish Law (1993) and "Asu Seyag Latorah: Make a Fence to Protect the Torah" in Re-examining Progressive Halakhah (2002).

Daniel Schiff is the Community Scholar of the Jewish Education Institute in Pittsburgh. He is rabbi of Temple B'nai Israel in White Oak, Pennsylvania. Born in Australia, he was educated at the University of Melbourne and the Hebrew Union College-Jewish Institute of Religion from which he was ordained and received his doctorate.
